I'm excited to announce that we're relocating our Sunrise branch to a new, fully renovated space! This move reflects our commitment to providing you with enhanced services and a modern banking experience, similar to the improvements we made at our Delray Beach branch.

To facilitate this transition, **our current Sunrise branch at 8850 W. Oakland Park Blvd. will permanently close on Friday, April 25<sup>th</sup> at 5:30 PM.** This closure includes all services: night drop, drive-thru, lobby transactions, and safe deposit box access.

## Why the Move?

PFCU owned the building housing the Sunrise branch. However, low occupancy in the additional office spaces and the building's increasing maintenance costs led to our decision to sell. As a not-for-profit financial cooperative, we are dedicated to responsible resource management. By selling the building, we can reinvest in you, ensuring continued competitive rates, low fees, and access to cutting-edge technology.

## Our New Location: Coming Fall 2025

Our **new branch will be in Plantation Square at 1739-B N. University Drive, Plantation, FL 33322**, just a short distance from the current Sunrise location. We anticipate opening in Fall 2025. We will notify you with the confirmed opening date and all relevant details as soon as they are available.
